## FASLODEX Patient Savings Program

The goal of the FASLODEX Patient Savings Program is to assist eligible patients with their out-of-pocket costs for FASLODEX® (fulvestrant).

Most eligible patients will pay **[\$0]** per dose and may have access to up to **[\$6,000]** per year to assist with FASLODEX out-of-pocket costs. There are no income requirements to participate in the program.

Talk to your doctor, who can help you enroll in the program and file claims on your behalf.

## Eligibility Requirements

- Must be a resident of the United States or Puerto Rico
- Patients must have commercial health insurance that covers medication costs for FASLODEX, but not the full cost to the patient

Patients are ineligible if prescriptions are paid by any state or other federally funded programs, including, but not limited to, Medicare Part B, Medicare Part D, Medicaid, Medigap, VA or TRICARE, or where prohibited by law. Eligibility rules apply. Additional restrictions may apply.

The FASLODEX Patient Savings Program covers the cost of the drug and administration, but does not cover costs for office visits or any other associated costs.

Offer is invalid for claims and transactions more than **[120]** days from the date of service.
